## WHAT DOES GRIFFIN OWENS INSURANCE GROUP DO WITH YOUR PERSONAL INFORMATION?

## Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

## What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Account number. address, social security number, and birth date
- Assets and investment experience
- Account balances, risk tolerance, payment history and employment information
- Net worth, assets, income, investment experience
- Medical information (if applying for insurance)

How?

All financial companies need to share some of its client's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their client's personal information; the reasons why Griffin Owens Insurance Group chose to share this information; and whether you can limit this sharing.

How does Griffin Owens Insurance Group protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings, as well as:  information access controls service provider oversight and confidentiality agreements

How does Griffin Owens Insurance Group collect my personal information?	<ul> <li>We collect your personal information from you, as well as from other sources. The sources and the information collected may include:</li> <li>Information you provide to us, or to the advisor on applications or related forms, and through discussions with our staff.</li> <li>Information regarding your transaction history with us.</li> <li>Information from other non-affiliated third parties, including employers,</li> </ul>	
	associations, benefit plan sponsors, and institutions, if you transfer accounts.  We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only:</li> <li>sharing for affiliates everyday business purposes — information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for non-affiliates to market to you</li> </ul>	
	State laws and individual companies may give you additional rights to limit sharing.	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
